3.127(d)

Facilities, outdoor.

On the southeast area of the park there are empty metal cages and stacks of cage panels piled against the perimeter fence. These stacks of cages and panels stair-step up to approximately 6 feet in height and extend 30 feet along the fence. Because of proximity to the perimeter fence these stacks provide a platform that reduces the effective height of the perimeter fence to approximately 2 feet. Animal well-being is compromised whereby an animal potentially escaping its enclosure could use this structure to facilitate escape from the park or lead to injury or death to the animal, other animals, or the public. The perimeter fence must be maintained so that it inhibits animals from going over the fence as well as functioning as a secondary containment system for the animals in the facility. Correct by removing objects and structures away from the perimeter fence to prevent animals from using them as a means of escaping over the perimeter fence. Correct by 25MAY2025.

3.131(c)

Sanitation.

In the area directly adjacent to the food storage and food preparation building there are piles of refuse including but not limited to broken or used wood pallets, scrap and stacked animal crates buried behind other debris inhibiting inspection in those areas and permitting hiding places for rodents to reside. The lack of housekeeping and sanitation attracts pests into the facility, resulting in unpleasant odors, and may contribute to the spread of disease. Accumulations of debris can provide areas which can harbor disease-transmitting pests and could increase health risks to the animals. Correct by ensuring that premises (buildings and grounds) are kept clean, in good repair and accumulations of trash are placed in designated areas and cleared as necessary in order to protect the animals from injury, protect their health, and to facilitate prescribed husbandry practices.

3.131(d)

Sanitation.

During the inspection, dead and dying flying insects and excessive amounts of rodent feces were found in food storage and processing areas. Rodent feces and flies were found including but not limited to the following areas:

- Around two pallets of loosely covered red meat in the storage freezer.
 - Next to totes of exposed meat, on food prep tables, and on the floor of the meat prep room.
